- 1. <u>Glycogen Standard</u> (Part No. 50221C): One 50 µL tube at 3 mM.
- 2. <u>10X Assay Buffer</u> (Part No. 268002): One 25 mL bottle of 500 mM sodium phosphate pH 7.4.
- 3. <u>Fluorometric Probe</u> (Part No. 50231C): One 50 µL tube in DMSO.
- 4. <u>HRP</u> (Part No. 234402-T): One 10 µL tube of a 100 U/mL solution in glycerol.
- 5. <u>Amyloglucosidase (Part No. 50223C)</u>: One 1 mL tube at 15 U/mL.
- 6. <u>Glucose Oxidase</u> (Part No. 50224C): One 100 μL tube at 100 U/mL.

SECTION 4. FIRST-AID MEASURES

- IF SWALLOWED, WASH OUT MOUTH WITH WATER PROVIDED PERSON IS CONSCIOUS. CALL A PHYSICIAN IF INHALED, REMOVE TO FRESH AIR. IF NOT BREATHING GIVE ARTIFICIAL RESPIRATION. IF BREATHING IS DIFFICULT, GIVE OXYGEN.
